Squamish Nation Territory/West Vancouver – It has been 22 days since the province of British Columbia declared a state of Emergency due to the COVID-19 outbreak. The damage has been significant and far reaching. However, in the face of these extraordinary challenges, AHMA has witnessed resilience in adversity.

AHMA raises our hands and expresses our sincere gratitude to the entire Indigenous Housing Community. The list of each individual is too long to inventory but includes: Housing & service providers, cleaning staff, security personnel, maintenance workers, food service workers, social workers and of course each and every health care worker on the front lines of this pandemic. You are the unsung heroes of our current COVID-19 response. It is through your courageous, committed efforts that allow our Indigenous communities to move forward through these unprecedented times.

AHMA continues working diligently alongside our partners and sector leaders to take all the necessary steps to protect the safety and health of our members and the Indigenous communities they serve. At BC Housing, Shayne Ramsay and the entire organization have been compassionate and responsive to AHMA, granting extra funding to support our members through this challenging time. BC Non-Profit Housing Association led by Jill Atkey and her exceptional staff have consistently provided access to the most accurate information and educational opportunities to not only AHMAs membership but to the entire non-profit housing community. Together we have hosted two free webinars to provide up-to-date housing and health information as well as provided opportunities for housing and service providers to ask questions in real-time during this unfolding crisis.

The Province of BC, Premier John Horgan and Minister Selina Robinson continue to take exceptional measures to support the housing sector. Finally, our Federal Government and Prime Minister Justin Trudeau have continued to provide the nation with economic measures to ensure that Canadians will get through this difficult time with as minimum damage as possible.
